

### Bahamas tourist visa checklist



**Filled out and signed Bahamas tourist visa application form.** The form is enclosed.



**Original Passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.



**1 Photographs.** Standard passport photographs 2x2 inches on a white background.



**Payment.** Credit Card Authorization form, Certified Check, or Money Order payable to **VisaHQ.ca**.



**Return mailer.** Prepaid self-addressed return label or payment for FedEx.



**Proof of Status.** ORIGINAL evidence of your legal status in Canada (Original of study permit, work permit, refugee/protected person status document).




**Itinerary.** Copy of round trip tickets or itinerary. **For multiple entry requests**, applicants are required to provide copies of all flight itineraries of trips they plan on taking. If applicant is not able to provide more than 1 flight itinerary the High Commission may not be able to grant a multiple entry visa.



**Hotel Reservations.** Copy of confirmed hotel reservations.

☐ **Personal Invitation.** If visiting friends or family, you must provide letter of invitation with the contact information of the host and visitor, purpose and duration of the visit, confirmation of accommodation including the address, signature and date. You will also need to provide proof of the host's status in Bahamas ie. copy of their Bahamas passport's information page, or, if they are not a citizen of Bahamas, copies of their Bahamas residence permit and their national passport's information pages.

☐ **Proof of Sufficient Funds.** You must provide proof of sufficient funds to finance the visit - an employment letter with position and length of employment OR a letter from a sponsor/employer/company who will be covering all of the applicant's expenses while in The Bahamas.




