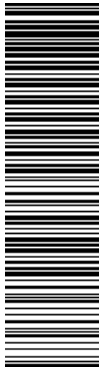

Original Passport. Passport must have at least 6 months remaining validity and have at least 1 visa page.



3 Photographs. Standard passport photographs 2x2 inches on a white background.



Payment. Credit Card Authorization form, Certified Check, or Money Order payable to **VisaHQ.ca**.



Return mailer. Prepaid self-addressed return label or payment for FedEx.



Itinerary. An airline booking reservation.



Yellow Fever Vaccination. A copy of the International Certificate of Vaccination (ICV) for yellow fever. To learn more about the yellow fever vaccination or to locate a vaccination clinic, please visit Health Canada's yellow fever resource centre.



Invitation letter. Invitation Letter requesting your presence in Burundi or hotel reservation.



Multiple Entry Letter. If multiple entries are desired, a detailed letter explaining precisely why the multiple entry visa is necessary. The decision to grant or deny the Multiple entry visa to Burundi lays entirely with the Burundi Embassy.

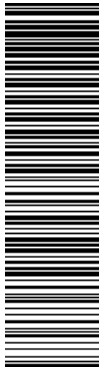

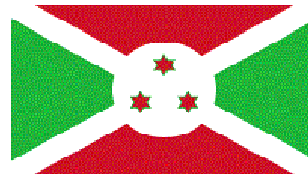
