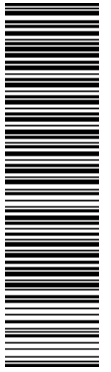

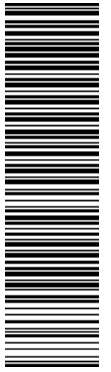

Equatorial Guinea tourist visa checklist

- ☐ **Filled out and signed Equatorial Guinea tourist visa application form.** The form is enclosed.
- ☐ **Original Passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.
- ☐ **2 Photographs.** Standard passport photographs 2x2 inches on a white background.
- ☐ **Payment.** Credit Card Authorization form, Certified Check, or Money Order payable to **VisaHQ.ca**.
- ☐ **Return mailer.** Prepaid self-addressed return label or payment for FedEx.
- ☐ **Itinerary.** Copy of round trip tickets or itinerary.
- ☐ **Yellow Fever Vaccination.** A copy of the International Certificate of Vaccination (ICV) for yellow fever. To learn more about the yellow fever vaccination or to locate a vaccination clinic, please visit Health Canada's yellow fever resource centre.
- ☐ **Bank Statement.** Whether traveling for tourism, you will have to present a bank statement or equivalent document showing the amount of at least \$ 2,000. Bank statement must show applicant's name.
- ☐ **Police Report.** Police report or Certificate of Good Conduct from applicant's local police station.
- ☐ **Invitation.** An invitation from the National Security Counsel in Malabo is required in order to obtain a visa.

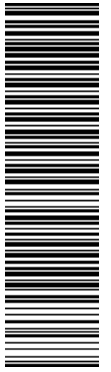
