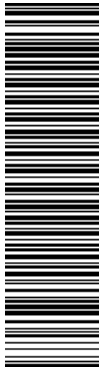

**Original Passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.

**Passport Photos:** 2 photos. Photo size **MUST** be 5x7 cm.

**Payment.** Credit Card Authorization form, Certified Check, or Money Order payable to **VisaHQ.ca**.

☐

**Return mailer.** Prepaid self-addressed return label or payment for FedEx.

☐

**Proof of Status.** Copy of the front and back of valid Permanent Resident Card or other proof of legal status in Canada (such as study permit, work permit, refugee/protected person status document)

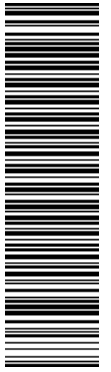

**Itinerary.** Copy of round trip **tickets or itinerary** (Applicant's name must be on itinerary)

**Employment/Enrollment Letter.** A letter from your employer on business letterhead, with contact details, describing your duties, and stating that a leave of absence has been granted, purpose and duration of the trip, and that you will be returning to your current job. For students, please submit an official letter from your school stating your course of study and indicating that you are in good standing and that you are registered for the upcoming semester. If you are retired please submit a personal letter explaining your employment history.

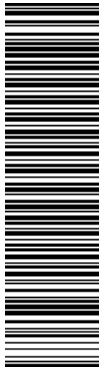

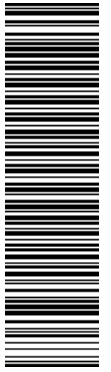
