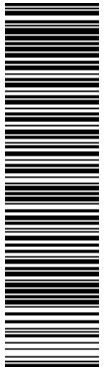

Russia passport holders with multiple entry US visas do not need visas for Serbia for stays up to 90 days as long as their visa covers their entire stay in Serbia.

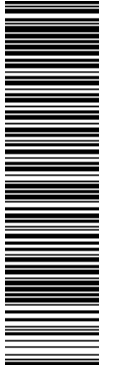


Serbia tourist visa checklist

- Filled out and signed Serbia tourist visa application form.** The form is enclosed.
- Original Passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.
- Passport-type photograph 1:** must be uploaded to your applicant profile.
- Payment.** Credit Card Authorization form, Certified Check, or Money Order payable to **VisaHQ.ca**.
- Return mailer.** Prepaid self-addressed return label or payment for FedEx.
- Itinerary.** Copy of round trip tickets or confirmed itinerary.
- Health Insurance.** Proof of health insurance covering international travel.
- Bank Statement.** Copy of a recent bank statement showing proof of sufficient funds.
- Letter of Invitation.** An official letter of invitation approved by the Ministry of Foreign Affairs in Serbia.

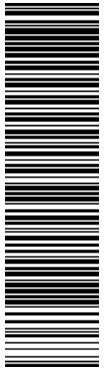
