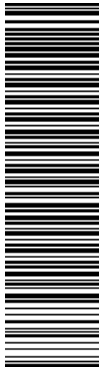

Please make sure that application forms are **not printed on double-sided paper**.

Beginning April 10, 2014, the Turkish Ministry of Foreign Affairs will no longer provide visas on arrival to foreign travelers. All foreigners must obtain their Turkish visas electronically prior to departure from their country of residence.

Travelers must present negative COVID-19 PCR test result issued within 72 hours of departure. And Health declaration form which you can obtain at VisaHQ. Without evidence of test and health form, passengers will be denied boarding. Please complete [Health Declaration form](#) here.



Turkey tourist visa checklist



Filled out and signed Turkey tourist visa application form. The form is enclosed.



Original passport. The passport must be valid at least 6 months after the intended date of departure from the territory of the destination country and has at least 2 blank visa pages.



Passport-type photograph. Include a passport style photo, with a white background, taken within the last 6 months. You may also choose to upload a photo to your order for us to print. There is a charge associated with this service.



Payment. Credit Card Authorization form, Certified Check, or Money Order payable to **VisaHQ.ca**.



Return mailer. Prepaid self-addressed return label or payment for FedEx.

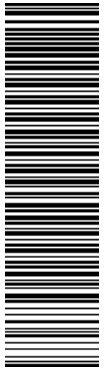


Proof of Status. Copy of the front and back of valid Permanent Resident Card or other proof of legal status in Canada (such as study permit, work permit, refugee/protected person status document)



Travel Insurance. All incoming travelers must have travel insurance that covers COVID-19 for the duration of their trip to Turkey

- ☐ **Hotel Reservations.** Copy of confirmed hotel reservations.
- ☐ **Personal invitation.** If staying with friends or family, a **NOTARIZED** invitation from the host in Turkey, may be used instead of a hotel reservation.
- ☐ **Proof of income.** Proof of income in Canada. Job letter along with 2 most recent pay stubs.
- ☐ **Health Declaration Form.** The form you will fill may be checked at the borders of Turkey whether you have filled in this form or not, and If you haven't filled in the form or made misleading statements, you may face legal and administrative sanctions. The form can be found here.

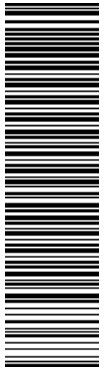
Additional required documents for minors

- **Personal letter.** Personal letter which indicates the reason of the trip, they are travelling with their children (who are the applicant and the dates of the travel .
- **Bank Statement.** Copy of the accompanying parent's bank statement.

All arriving travelers who have visited Brazil, the UK, Denmark or South Africa within the last 10 days will be subject to a 14-day quarantine on arrival at locations selected by the local Turkish authorities. Travelers in quarantine will be given a mandatory PCR test on day 10 of their quarantine, if the result is negative the quarantine period will end.
