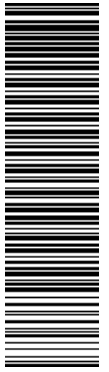

Payment. Credit Card Authorization form, Certified Check, or Money Order payable to **VisaHQ.ca**.

Return mailer. Prepaid self-addressed return label or payment for FedEx.

☐

Payment Authorization. Complete and sign the Credit Card Authorization Form.

☐

Proof of Status. Copy of the front and back of valid Permanent Resident Card or other proof of legal status in Canada (such as study permit, work permit, refugee/protected person status document)

Itinerary. Copy of round trip tickets or confirmed itinerary.

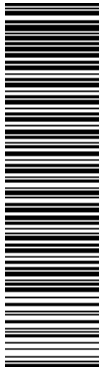

☐ **Personal Invitation.** If visiting friends or family, you must provide letter of invitation with the contact information of the host and visitor, purpose and duration of the visit, confirmation of accommodation including the address, signature and date. You will also need to provide proof of the host's status in Zimbabwe ie. copy of their Zimbabwe passport's information page, or, if they are not a citizen of Zimbabwe, copies of their Zimbabwe residence permit and their national passport's information pages.

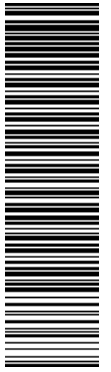

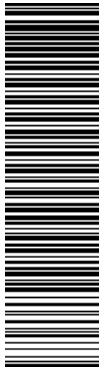
